




This chart shows the total general purpose revenue Northern United - Humboldt Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Northern United - Humboldt Charter School is \$5,908,785, of which \$4,302,727 is Local Control Funding Formula (LCFF), \$239,057 is other state funds, \$904,837 is local funds, and \$462,164 is federal funds. Of the \$4,302,727 in LCFF Funds, \$913,539 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



The text description of the above chart is as follows: In 2022-23, Northern United - Humboldt Charter School's LCAP budgeted \$881,967 for planned actions to increase or improve services for high needs students. Northern United - Humboldt Charter School actually spent \$869,943 for actions to increase or improve services for high needs students in 2022-23.

The difference between the budgeted and actual expenditures of \$-12,024 had the following impact on Northern United - Humboldt Charter School's ability to increase or improve services for high needs students:

Though our actual expenditures for actions and services to increase or improve services for high needs students in 2022-2023 is less than the total budgeted expenditures for those planned actions and services, we budgeted more expenditures than the supplemental/concentration revenues we were allocated. In other words, we spent all of the revenue we received for high needs students. We budgeted even more expenditures than we received to target those students.

## **Plan Summary [2023-24]**

## **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Northern United - Humboldt Charter School petitioned Humboldt County Office Education to become the first countywide benefit charter in Humboldt County. Northern United - Humboldt Charter School's petition was approved on February 14, 2018. Northern United - Humboldt Charter School serves students in grades TK-12, with six facilities throughout Humboldt County. We are WASC accredited and are an AVID certified school. We offer our students a variety of instructional opportunities including field trips, enrichment classes, concurrent and dual enrollment, CTE pathways, and TRIO.

Northern United – Humboldt Charter School students are educated through personalized learning programs. Within that context, students may receive their instruction through home-based learning or through attendance at a learning center. Students who select home-based learning meet with their teacher on a schedule that accommodates their educational needs. They may also participate in classes with other students at one of our facilities. Students who chose to attend one of our learning centers meet with their teachers on a more regular basis.

Because all of our students are independent study, parents play a vital role in their student's education. The program parents select determines the degree to which the parent is involved. The parents can become the primary facilitators of their child's learning program if they choose. Professional learning and parent education are available and encouraged. We work with all of our students and parents by providing them with educational resources, a credentialed teacher, and access to a team of educational staff. Parents/guardians and their children collaborate with their teachers to determine their educational goals and objectives, create their individualized curriculum, and determine their individual methods of teaching and learning.

Northern United - Humboldt Charter School provides a safe environment and positive culture for our students. We utilize PBIS, a behavioral framework, to help support our students achieve improved social and academic outcomes. We are an ALICE-certified school with staff who are trained in active shooter response. To help support the social/emotional needs of our students, we offer an Outdoor Resiliency Building Education program, as well as counselors and school psychologists.

### **Reflections: Successes**

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

Based on a review of the California School Dashboard and our local data, we had several successes over the course of the year. We did see an increase in the number of CTE pathways we offer. In addition to a pathway in building trades and a pathway in horticulture, we began a pathway in mental and behavioral health. We also had an increase in the number of students college ready in E/LA as demonstrated in the EAP. In 2020/2021, we had a 31% college ready rate in E/LA and in 2021/2022 it increased to 47.06%. Another success was our increase in the satisfaction students feel about their academic program. It increased from 50% to 100%. Maintaining a 100% rate of students feeling safe is also a success. We made progress on increasing our attendance rate and decreasing our chronic absentee rate. Though it still isn't where we'd like it to be, we are moving in the right direction.

## **Reflections: Identified Need**

Our CAASPP scores decreased so this will continue to be a priority for our school and we qualified for Additional Targetes Support and Improvement. This can occur when one or more school level student groups has all indicators at the lowest status, but one indicator at another status level. This occured for our student group of multiple races. In other words, all of their indicators except one were in the lowest status. In our specific situation, due to the small number of students in this student group, only two indicators are reported and one is red (the lowest status) and one is blue.

We also saw a decrease in our graduation rate changing from 84.2% to 74.4% and an increase in our high school dropout rate with a 10.5% rate in the 2020-21 school year and 25.6% in the 2021-22 school year. Our chronic absenteeism for all students decreased from 17.9% to 12.4%, but is still too high. All of these areas will be a focus moving forward.

## **LCAP Highlights**

When creating our LCAP, we proceeded to change from three goals to two goals. We based our decision on the fact that we believed this change would make our LCAP more user-friendly and more concise in nature. Moreover, we felt that having a brief but comprehensive LCAP would make sharing our LCAP information with our educational partners easier to understand and promote greater communication,

input, and involvement in the process in the upcoming years. We have found this decision to be successful; therefore, we will be continuing with our two goals.

Based on feedback that was received from our educational partners, we will continue placing emphasis on the academic and social/emotional needs of our students. With an increase in our counseling staff and expanded opportunities for our Outdoor Resiliency Building Experiences program and, continued interventions from our Intervention Coordinator overseeing our SSTs that address both behavioral and academic issues, all students will be supported in a very direct manner at the first signs of student struggle.

We will be continuing some of our past actions placing emphasis on specific targeted areas. With our tutoring and intervention curriculum along with our Renaissance assessments and interim CAASPP assessments, teachers are able to provide students with targeted support in areas in which students struggle. Finding that our CAASPP scores decreased during the 2021/2022 school year, Northern United - Humboldt Charter School will continue to address students' needs in this area. By monitoring students' growth with our internal data, Renaissance STAR testing, teachers are able to support students immediately in both E/LA and Mathematics. We will continue to put a focus on this support, as well as placing additional emphasis on the CAASPP interim assessments.

Additionally, by continuing to offer our students various CTE pathways, we give them opportunities to explore career options while experiencing academic rigor. We will be continuing with our CTE pathways with hopes of expanding our offerings over the next several year.

Other important highlights of our LCAP surround continuing to offer A-G coursework that is both high-interest and provides rigor for our students. While this is a continued action, we will place targeted emphasis on the addition of more A-G classes with the intention of seeing all high school students taking these courses.

# **Engaging Educational Partners**

A summary of the process used to engage educational partners and how this engagement was considered before finalizing the LCAP.

Northern United - Humboldt Charter School understands that community input is important because parents, students, and staff can use the LCAP process to advocate for funds to meet their specific school needs, such as additional counselors, programs, and tutors. To gather feedback, we distributed three different surveys. The surveys focused on school climate, family engagement, California state standards curriculum and implementation. The surveys were distributed to parents, students, and staff. The School Climate Survey, the Family Engagement Survey and the Implementation of State Standards Survey were all distributed on February 1, 2023 and again on March 23, 2023. The surveys were emailed and sent out on Parent Square. In total, we received feedback to our surveys from 88 educational partners.

Input was also solicited through LCAP meetings held at our learning centers. These meetings occurred on February 9th, March 29th, and April 5th. With only twenty five education partners attending these meetings, participation was less than hoped for. This year a Parent Advisory Council (PAC) was formed with the purpose of seeking guidance and input on the LCAP. This group is made up of eight members and met on April 25, 2023. Input was also gathered at a teacher meeting on April 3, 2023. Additionally, partners had the opportunity to give feedback at Northern United Charter Schools' Board meetings. A public hearing was held on June 28, 2023, with plan adoption on June 29, 2023.

Northern United - Humboldt Charter School does not have an ELAC group due to the low number of EL students. Also, NU-HCS does not have a bargaining unit.

#### A summary of the feedback provided by specific educational partners.

Based on the information we received, our educational partners responded that they feel well informed regarding their student's educational needs. Another area that educational partners addressed was how well our school individualizes learning and provides flexibility for each student and their specific needs. Our small class sizes, teacher-to-student ratio, community building, and positive, safe learning environments were all mentioned as strengths.

Our educational partners also responded about those areas in which they saw a need for our school to improve or continue to add to moving forward. There was a theme in our educational partner's responses regarding the social-emotional needs of our students and parents and how more services should be available. There also seemed to be a concensus among the educational partners that more elective choices should be made available to our student body and more support is needed to help students fill in gaps in learning.

As a result of our educational partner's feedback, we included maintaining our communication strategies within the actions of our LCAP. We'll continue to produce newsletter and utilize ParentSquare. Because of the feedback we have received, Northern United-Humboldt Charter School has added more elective courses, including an additional CTE pathway. In an effort to support students social/emotional needs, as well as their gaps in learning, we will continue to fund two counselors, as well as an RTI coordinator and a math intervention specialist. Additionally, we will continue to partner with community vendors and tutors.

## Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

We did complete the actions we planned to take in order to meet this goal. However, during the school year, a teacher resigned and it took us several months to replace her. Additionally, we were unable to hire a response to intervention coordinator until March. Until then, these duties were being shared by several staff members. Also, we contracted with less vendors that we originally planned. This was due to the requirement of vendors to be fingerprinted and TB tested. Many local agencies were unwilling to comply with these requirements.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Material differences between Budgeted Expenditures and Estimated Actual Expenditures are noted as follows:

- 1.6 Employ academic counselor: This difference is due to a miscalculation on the estimated expenditures in planning the 2022-2023 LCAP.
- 1.7 Employ instructional aides: One instructional aide who was originally budgeted for became a certificated employee.

An explanation of how effective the specific actions were in making progress toward the goal.

The specific actions taken by Northern United - Humboldt Charter School to target student academic improvement were not as successful as we had expected them to be. Unfortunately, we did not see the gains in our CAASPP scores that we had hoped to see for all students. However, students with exceptional needs and our Hispanic subgroup did show some growth in E/LA. By using the interim assessments, teachers were able to gain information about student strengths and areas for improvement, however our Star Renaissance scores also showed a decline in student growth. Another focus area has been in the area of our College and Career Indicators. Though we have been placing emphasis on CTE Pathways and A-G coursework, Northern United - Humboldt Charter School showed a decrease in the number of students completing a CTE pathway and in the percent of students graduating with A-G eligibility. We did, however, see an increase in the number of CTE pathways we offer and an increase in the number of students college ready in E/LA as demonstrated in the EAP.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

Northern United - Humboldt Charter School does not plan to change this goal or the actions associated with it. We now have an RTI Coordinator on staff and we are hoping this added focus to academic intervention will support student growth.

## Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year.

A description of any substantive differences in planned actions and actual implementation of these actions.

The actions related to this goal were implemented in much the same way that we have done over the past years. In an analysis of this goal, we did accomplish our planned actions, however it is clear that more emphasis needs to be placed on the importance of involvement in our school. We had very low participation in our surveys and a decrease in parent participation and parents feeling they have input in decision making. Also, our food service coordinator resigned in the fall and her replacement went on medical leave so it has been a struggle implementing action 2.6. On a positive note, we formed a social/emotional learning (SEL) team to help support the needs of our students. Through the course of this year, the SEL team developed a school vision and SEL priorities. Finally, as stated in the analysis of Goal 1, we recently hired an intervention coordinator and we're hopeful that filling this position will have positive impacts on student behavior.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Material differences between Budgeted Expenditures and Estimated Actual Expenditures are noted as follows:

- 2.1 Increase parent communication: We spent more than we originally estimated due to an increase in staffing costs.
- 2.6 Offer food program: We spent less on staffing than we originally estimated. This is because we had turn over in our food service staffing.

An explanation of how effective the specific actions were in making progress toward the goal.

We had a decrease in the percent of parents who are satisfied with our school, however the student satisfaction and feelings of safety remain high. We also saw a reduction in our graduation rate, changing from 84.2% to 74.4%, and in increase in our high school dropout rate with a 10.5% in the 2020-21 school year and 25.6% in the 2021-22 school year. Our chronic absenteeism rate for all students decreased from 17.9% to 12.4%, but increased for students of multiple races. This year we qualified for Additional Targeted Support and Improvement. This can occur when one or more school level student groups has all indicators at the lowest status, but one indicator at another status level. This occurred for our student group of multiple races. In other words, all of their indicators except one were in the lowest status. In our specific situation, due to the small number of students in this student group, only two indicators are reported and one is red (the lowest status) and one is blue. These swings in rates are in part explained by our small sample sizes. Each student makes a large difference in a small school.

A description of any changes made to the planned goal, metrics, desired outcomes, or actions for the coming year that resulted from reflections on prior practice.

In reflection of our practice, it is clear that an increase in communication with our parents, students, and staff regarding the importance of their participation and input is needed. We do not plan on changing this goal or any actions, however we did add a metric and outcome. The metric and outcome is related to the chronic absentee rate for students of multiple races.

For each action being provided to an entire school, or across the entire school district or county office of education (COE), an explanation of (1) how the needs of foster youth, English learners, and low-income students were considered first, and (2) how these actions are effective in meeting the goals for these students.

Goal #1 Action 2 - Employ highly qualified content area specialists

By providing additional resources in specific content areas to unduplicated youth, the students will have more direct instruction and support toward making progress in academic content standards. A review of our previous CAASPP data, as well as our local assessment data, showed that our unduplicated students were underperforming in academic areas. By providing highly qualified teachers, unduplicated students will receive the academic support through direct instruction necessary to achieve academic expectations because there will be a lower adult/student ratio which provides more direct instruction and support for unduplicated students. After an analysis of data reflecting student success, we determined that unduplicated students were disproportionately scoring lower on both standardized testing and our internal STAR Renaissance assessments. This prompted the creation of an action to address additional academic support for students. We expect our student success metrics will increase for all students, however, unduplicated students will receive the largest benefit by having content area specialists. The more one-on-one attention and individualized teaching students can glean, the higher the quality and personalization of their learning. A lower ratio tends to indicate a more positive and tailored teaching approach that benefits high need students.

#### Action 5 - Implement academic RTI

By employing an Intervention Coordinator, additional tutors, administering the Renaissance assessment, and providing an intervention curriculum, we will be able to provide targeted intervention for specific gaps in learning or learning loss for unduplicated students. The intervention coordinator will be responsible for progress monitoring for students who fall within the unduplicated categories. The needs of our unduplicated students were considered first by an analysis of our data that showed these students were underperforming in academic areas. By implementing academic RTI, unduplicated students will have access to the appropriate curriculum and staff in order to achieve academic expectations. To improve our academic performance we will have an intervention coordinator in both E/LA and mathematics, as well as a Data Champion at each learning center to lead data analysis efforts and create an early warning system that uses individual student data to generate indicators of "on-track" status and enable staff to identify and monitor progress of students falling below an identified threshold, and work with teachers to consider additional actions and services designed to help each student improve his or her performance. This action will be effective because it will allow us to better understand the needs of each individual student through an analysis of periodic screening data, a personalized intervention plan, and an expansion of one on one tutoring opportunities.

#### Action 6 - Employ an academic counselor

By employing an additional academic counselor, unduplicated students will receive more academic, college/career, and transition plan guidance. The focus will be placed on post-secondary transitional planning in order to ensure the success of unduplicated students after high school. Because our unduplicated students are not meeting their expected academic progress, we considered how increasing our academic counseling staff could enhance a student's access to a broad course of study and increase the rate of unduplicated students' success. By providing additional academic counseling, all students will benefit, but the strategies will be principally directed to unduplicated students. Because our unduplicated students are not meeting their expected academic progress, we considered how increasing academic counseling staff could enhance student access to a broad course of study and overall academic success rate of unduplicated students' success. By employing an additional academic counselor, unduplicated students will receive more academic, college/career, and transition plan guidance. The focus will be placed on postsecondary transition planning in order to ensure the success of unduplicated students after high school.

#### Action 7 - Employ instructional aides

By employing additional instructional aides there will be a lower adult/student ratio which provides more direct instruction and support for unduplicated students. After an analysis of data reflecting student success, we determined that unduplicated students were disproportionately scoring lower on both standardized testing and our internal STAR Renaissance assessments. This prompted the creation of an action to address additional academic support for students. We expect our student success metrics will increase for all students, however, unduplicated students will receive the largest benefit by having instructional aides. The more one-on-one attention and

individualized teaching students can glean, the higher the quality and personalization of their learning. A lower ratio tends to indicate a more positive and tailored teaching approach that benefits high need students.

#### Action 8 - Provide materials and supplies

By providing materials and supplies, including backpacks, gas mileage reimbursements, and bus tickets for all students, including unduplicated youth, we will remove barriers from learning that might otherwise stand in the way of their academic success. Unduplicated students, low-income students in particular, often lack the supplies they need to be successful. By providing materials and supplies, all of our students receive the educational materials they need to be successful, but our unduplicated students principally benefit. By providing materials and supplies, including backpacks and bus tickets or van transportation to unduplicated youth, we will remove barriers that limit their access to our educational program and from learning that might otherwise stand in the way of their academic success. This action is available to all students, but is principally directed towards SED and other unduplicated students.

#### Action 9 - Provide educational technology

By providing educational technology to unduplicated youth, we will ensure that unduplicated youth receive access to educational opportunities. Unduplicated students often face barriers regarding internet access and educational technology. This leads to less academic engagement. By providing hot spots and Chromebooks to students, all of our students receive access to the internet, but our unduplicated students principally benefit because the barrier of access is removed. By providing Chromebooks, hotspots, and bus tickets or van transportation to unduplicated youth, we will remove barriers that limit their access to our educational program and from learning that might otherwise stand in the way of their academic success. This action is available to all students, but is principally directed towards SED and other unduplicated students.

#### Action 12 - Provide CTE pathways

By providing additional CTE pathways to all students, unduplicated youth will receive instructional programs to ensure college and career readiness. Because our unduplicated students, especially socioeconomically disadvantaged students, are less likely to be "prepared" for College/Career Readiness than all students, providing engaging, hands-on opportunities to experience a-g courses and CTE pathways, will ensure that unduplicated students will gain the necessary skills to be prepared to enter college or the workforce. Additional CTE pathways will allow more students to benefit, however, our unduplicated students will receive the greatest benefit from greater student engagement; therefore, those meeting the "prepared" level for the College/Career Readiness indicator should increase. Because we have such a high rate of unduplicated students, any action to increase college readiness will benefit those students. Working towards ensuring that all students gain the necessary skills to be prepared to enter college or the workforce by having access to a broad course of study will help our

traditionally underserved students as well. By hiring an CTE teachers CTE and creating new pathway opportunities, and contracting with the county office of education, we will become more effective at preparing all students for post secondary plans.

By providing additional learning opportunities in PBIS, Second Step, etc. staff will gain additional knowledge to help support unduplicated student's behavioral and emotional needs. Because our unduplicated students are overrepresented in our dropout rate, suspension rate, and chronic absenteeism, providing professional learning in social/emotional, climate and engagement strategies, our staff will gain knowledge to address the specific barriers that unduplicated students face in their academic success. Professional learning in SEL provides staff with increased strategies to support student engagement for all students, therefore the overrepresentation of unduplicated students in our dropout and suspension rate should decrease. Because our unduplicated students are overrepresented in our dropout rate, suspension rate, and chronic absenteeism, providing professional learning in social/emotional, climate and engagement strategies, our staff will gain knowledge to address the specific barriers that unduplicated students face in their academic success. Because our unduplicated students are overrepresented in many of our school metrics, including dropout rate, suspension rate, and chronic absenteeism, employing an additional school counselor will benefit and add to the unduplicated students' success. By offering a food program, we will remove barriers from learning that might otherwise stand in the way of their academic success. By providing additional learning opportunities in PBIS, staff will gain additional knowledge to help support unduplicated student's behavioral and emotional needs. By employing an additional counselor who will be addressing the social/emotional needs of students, unduplicated youth will receive additional support in addressing their mental health.

The additional concentration grant add-on funding was used to increase our counseling staff. Based on feedback from our educational partners, it was clear that we needed extra counseling staff to address both the social and emotional needs of students, including unduplicated youth. With one counselor paying close attention to this identified need, our other counselor is able to use their energies in the academic realm. We see that having two couselors is a great addition and allows more support for all students, including foster youth, English learners, and low-income students.

The LCAP development process serves three distinct, but related functions:

# Goals and Actions

# **Purpose**

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100 percent attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
